### **Turn-in Area:**

Each competitor shall turn in his/her box at the front of the Premier BBQ & Fire store. From there, it will be carried inside to the judges where judging will be blind.

### **General Rules**

- Competitors must register using the online form at [nvbbq.org/bbqsocial](http://nvbbq.org/bbqsocial)
  - **Your registration must be received by 11:59pm December 1st, 2021.**
- A parent or guardian must be present for the child during the entire cooking competition.
- **The KidsQue is open to ages 7 - 16.** At this time, all competitors will be in one age group. If the number of registrations indicate that separate age groups are needed, they will be split into groups of ages 7-11 and ages 12 - 16. Competitors will be notified if the decision is made to split into separate age groups.
- The competitor must prepare, cook and present their entry. Children will place his/her meat on the grill, turn his/her meat on the grill, and remove meat from the grill. If your child cannot do this, then the child should not participate in the contest.
  - Parents/guardians may help with lighting the fire and knife handling but should strive to stay in an unobtrusive, supervisory capacity. Please let your kids cook. :-)
- Competitors are responsible for bringing cooking equipment and any supplies needed to execute the cooking process. The Nevada BBQ Association will provide the turn-in meats/protein during the cooks meeting.
  - **If you need help sourcing a grill or equipment, please contact us. We're happy to help.**
- Any fuel source is permitted; electricity will not be provided.
- The NVBBQA will provide two (2) pork chops during the cooks meeting. Competitors must use the provided proteins.
- A turn-in box will be provided. The turn-in box should consist of one, uncut pork chop. **Garnish is not permitted.**
- The pork chops may be seasoned, marinated, or glazed as the competitor desires. The pork chop must be turned in without any excessive pooling of sauces or butters.
- There will be a twenty minute "open turn-in window" for each category - late turn-ins will not be accepted.

- Example: the 2:00pm turn-in window is from 1:50pm to 2:09:59pm. At 2:10pm turn-in is late and will not be accepted.
- Competitors must check in and will be assigned a cook area.
- Judging will be based on appearance, tenderness/texture and taste.
- The NVBBQA will reserve all rights and judgements as to any situations that may arise during the event.

### **Additional Information:**

#### **What's Nearby**

The shopping complex where the competition will be held has a Vons grocery store with a Starbucks. There is also a brewery and a few restaurants that have American, Mexican, Mediterranean, Japanese, vegan and Pho options. Premier BBQ and Fire will also be open for sales.

#### **COVID**

In the state of Nevada, the governor has set pretty strict COVID regulations. When we can't social distance, we are required to wear masks. You must wear a mask when you enter any business or the business could get in trouble. All persons in counties with "substantial" or "high" community transmission rates will be required to wear face coverings while in public indoor spaces regardless of vaccination status.
